

CONDITIONS OF USE

Conditions of access and use of the Website

The user commits to make diligent use of the Website and services accessible from this Website, in full compliance with the Law, good practices and these General Conditions and, where appropriate, particular conditions, as well as maintaining due respect to other users.

Any use other than the purpose of this Website is expressly prohibited.

In this sense, the User will renounce to the use of any of the materials and information contained in this Website for illegal purposes and expressly prohibited in these General Conditions of Use, as well as the particular conditions that, where appropriate, are enabled that are contrary to the rights and interests of MEDICINA MATERNOFETAL BCN S.L., its members and/or third parties, and must respond to them in case of contravening or breaching said obligations and/or that, in any way (including introduction or dissemination of "computer viruses"), damages, disables, overloads, deteriorates or prevents normal use of materials and information contained in the Website, information systems or documents, files and all kinds of content stored in any computer equipment (hacking) of MEDICINA MATERNOFETAL BCN S.L., its members or any User of the Website.

In general, provision of services does not require prior subscription or registration of Users.
